(the “**Company**” or “**Dominion**”), pursuant to articles 227 and 228 of the Royal Legislative-Decree 4/2015, dated 23 October, approving the consolidated version of the Spanish Securities Market Act, articles 5 and 17 of Regulation (EU) no. 596/2014 on Market Abuse and the Delegated Regulation (EU) 2016/1052 supplementing Regulation on market abuse with regard to regulatory technical standards for the conditions applicable to buy-back programmes and stabilisation measures, and other applicable regulations, hereby reports the following

NOTICE OF OTHER RELEVANT INFORMATION

As a continuation of the notice of other relevant information published on November 2, 2022 (registration number 18967) relating to the establishment of a share buy-back programme, the Company hereby reports the transactions carried out over its own shares between 6 and 8 February 2023 (both inclusive), under the share buy-back programme approved by the Board of Directors of the Company in accordance with the authorization granted by the General Shareholders’ Meeting.

In addition to the above, Global Dominion Access reports that, after the last of the reported acquisitions, the Company has reached the maximum number of shares (1.526.667, representing approximately 1% of the Company’s share capital) prescribed in the share buy-back programme. The shares have been acquired for a cash amount of EUR 5.6 million, equivalent to an average price of EUR 3.67 per share.

Consequently, it is hereby reported that the share buy-back programme has come to an end prior to its maturity. The purpose of the programme was to purchase shares to be allocated to employees or to members of the administrative, management or supervisory body of Dominion or of a company within the Dominion Group.

The acquisition of the own shares under the share buy-back programme has been periodically communicated, in accordance with articles 2.2 and 2.3 of Delegated Regulation (EU) 2016/1052.
