Pursuant to article 17 of the Regulation (UE) no. 596/2014 on Market Abuse, to article 228 of the Royal Legislative-Decree 4/2015, dated 23 October, approving the consolidated version of the Securities Market Act and to Section Four of Regulation 1/2017, dated 26 April, of the National Stock Exchange Committee, on liquidity agreements, regarding the liquidity agreement executed on 3 July 2017 with JB Capital Markets, S.V., S.A.U., which entered into force on 11 July 2017, Global Dominion Access, S.A.
