RELEVANT INFORMATION NOTICE

Pursuant to article 17 of the Regulation (UE) no. 596/2014 on Market Abuse, to article 228 of the Royal Legislative-Decree 4/2015, dated 23 October, approving the consolidated version of the Securities Market Act and to Section Four of Regulation 1/2017, dated 26 April, of the National Stock Exchange Committee, on liquidity agreements, regarding the liquidity agreement executed on 3 July 2017 with JB Capital Markets, S.V., S.A.U., which entered into force on 11 July 2017 and was resumed on 12 March 2018 after being suspended on 20 November 2017, Global Dominion Access, S.A. (i) informs that no transaction made between 1 April 2018 and 30 June 2018, both included, was executed as a block trade or bilaterally-agreed transaction and (ii) discloses the summary of the transactions made during such period, as attached to this relevant information notice.
